

Advertisement Agreement

This Agreement was made on the _____ day, in the Month of _____, 2017 between Advertiser's Name, (hereinafter called "Advertiser") and the Chiangmai Expats Club (hereinafter called "CEC") in which both parties agree as follows;

1. In consideration of this Agreement by the Advertiser to pay the CEC the following;
 - a. The sum of 1,800 THB to advertise one month or
 - b. The sum of 0,000 THB to advertise for [???] months.
 - c. All fees are considered earned upon receipt.
2. The CEC agrees to provide the advertisement from First of month to end of month as stated below;
 - a. The Advertiser's advertisement or special promotion shall be displayed on the CEC Facebook page, with link to the Advertiser's website.
 - b. CEC shall give the Advertiser prominent coverage for a specific event, program or promotion relevant to the CEC membership in the e-newsletter published 3 times a month.
3. The CEC may allow the following;
 - a. The ability to possibly announce a special promotion at a General Meeting, upon prior approval and at the sole discretion of the Advertiser Manager.
4. The Advertiser agrees to the following;
 - a. To provide beneficial/useful products, services and/or information to our CEC members.
 - b. To email publicity and news of activities within their organization that may be of interest to CEC members, for consideration, as articles in the CEC e-Newsletter and Facebook. Text should be sent via email and shall be in Word format and artwork shall be in JPEG or PNG format.
 - c. Advertisers are solely responsible for the legality of the products, services and/or activities provided to the CEC or its members. CEC assumes no responsibility for any products, services or activities provided by the sponsor.
 - d. The Advertiser shall not seek business by claiming their organization as an official representative, sponsor or spokesperson for CEC.
 - e. The Advertiser will not have exclusive promotional and advertising right at any CEC event. The CEC, at its sole discretion, shall determine which Sponsors, Advertisers and others may participate in all CEC Events.
 - f. The Advertiser shall not promote more than two products and/or services per this Agreement unless otherwise agreed to by the Advertiser Manager.
 - g. It is agreed that all matters relating to the administration of the advertising shall remain the sole responsibility of the CEC.
5. The Advertiser shall notify the Advertiser Manager one week before the expiration of their advertising period regarding the extension of their advertising agreement.
6. This Agreement is renewable and can be extended upon mutual agreement of the parties and confirmed via e-mail, provided that payment in full for the extended advertising period has been received by the CEC.
7. The Advertiser at its discretion may terminate this Advertisement Agreement at any time, by providing 10 days written notice to the CEC; however, previously paid advertising fees are non-refundable.

8. The CEC retains the sole right to terminate this Advertisement Agreement without notice, should the CEC Board determine, at its sole and absolute discretion, that the Advertiser has or may cause discredit or disrepute to the CEC. In this case, the CEC will refund to the Advertiser, any prorated unearned portion of the advertising fees already paid.
9. This Agreement is made solely between the CEC and the Advertiser and shall not be assigned, except with prior written consent of the CEC.
10. Changes may be made during the term of this Agreement only with mutual written consent of the parties.
11. The Advertiser and the CEC intend that this agreement; represents the final expression of the parties' intent and agreement between the parties relating to the subject matter of this agreement, contains all the terms the parties agreed to relating to the subject matter, and replaces all the parties' previous discussions, understandings, and agreements relating to the subject matter.
